



# INTRODUCTION

### Aim: To understand and build upon previous work to roll out the CPMS in your context

This quick assessment checklist will support inter-agency groups to determine what activities are needed to support the implementation of the 2019 CPMS in your context. It recognises that in many humanitarian responses, a significant amount of work was done to implement the 2012 edition of the CPMS, and seeks to guide humanitarian actors on how to build upon that legacy.

# **INSTRUCTIONS**

### Who should complete the checklist:

Inter-agency child protection coordinators together with national actors, government partners and other humanitarian actors familiar with the work done on the CPMS to date

#### How to complete the checklist:

- **1.** Hold a meeting with the stakeholders listed above.
- 2. Discuss each of the four categories of activities (contextualise, raise awareness, build capacities, and institutionalise and monitor) and list the activities completed previously in the "2012 CPMS Implementation" column, noting when previous activities were carried out.
- **3.** Choose whether the majority of your activities were carried out <2 years ago, 2-3 years ago, or 3+ years ago or never.
- 4. Consider the activities proposed in the corresponding row of the "Suggested Next Steps" column.
