Introduction

Since COVID-19 was declared a global pandemic, the Alliance for Child Protection in Humanitarian Action (the Alliance), has been working to produce and disseminate much needed technical guidance, advocacy material, best practices, and other technical material in relation to the impact of the pandemic on the protection of children. Therefore, this work plan sets out the interagency standard setting and normative work of the Alliance, which aims to continue the prevention and response to infectious disease outbreaks, specifically COVID-19 and adaption of child protection programs in humanitarian settings.

The Alliance

The Alliance is a global network of operational agencies, academic institutions, policymakers, donors and practitioners that support the efforts of humanitarian actors to achieve high-quality and effective child protection interventions in all humanitarian contexts. The Alliance achieves this primarily by facilitating inter-agency technical collaboration, including production of technical standards and tools, on child protection in all humanitarian contexts. The Alliance's work falls into five broad categories: *Standard setting and guidance development, Capacity building, learning and development, Evidence and knowledge generation, Advocacy and Convening.* The United Nations Children's Fund (UNICEF) co-leads this network with a rotating organization. Plan International is the co-lead for 2019-2021.

The Alliance is structured as an open and non-competitive network of organizations and individuals with interest in the protection of children in humanitarian settings. It has a Steering Committee composed of representatives from the 18 core members, composed of UN agencies, INGOs and NGOs and observer representative from the Child Protection Area of Responsibility (CP AoR). The Steering Committee has primary authority and responsibility on matters of strategic significance and governance issues.

Working Groups, Task Forces and technical focal points implement the Alliance work-plan. Working Groups and Task Forces are led by members of the Alliance and supported by Alliance coordinators. Working Groups are permanent work streams, while Task Forces are expected to serve a specific technical function and dissolve once the task is completed. Technical focal points are individuals, within member agencies of the Alliance, who have agreed to act as an inter-agency resource on a given technical area of child protection, where no working group or task force exists.
